**FINANCIAL REPORT**

**DIRECTOR'S REPORT**

- ECSO has 3 new trainees. 2 positions remain unfilled; CritiCall testing will start again soon.
- Recent meeting minutes have not been posted to the website due to an error. This has been corrected. Corey Nelson will also be rolling out a new website design in the future.
- ECSO accreditation process is nearing end and appears to have been successful.

## **OLD BUSINESS**

### **Radio Study**

In January, a workshop was held using grant money to develop a plan for the radio system in Jackson County. The report has come back with short term and long term recommendations. The CEO Board will discuss the report and likely form a committee. Council members may call or email Margie Moulin with questions or to acquire the full report.

## **NEW BUSINESS**

### **XMU**

ECSO has requested from the state a system that will minimize the number of accidental calls placed to 911 from cell phones. The XMU system would require a wireless caller to make noise or press a button to reach a call-taker. There is normally a prohibition on installing an automated message system on 911; however, an exception can be made by the state specifically for screening unintended calls.

This would reduce call load in the call center by approximately 11,000 calls a year (based on statistics from other centers that use the system), plus the auxiliary calls and follow-up work that they cause. The system would not cost ECSO anything; it is paid for at the state level.

The level of service to the public would not be reduced by this system; however, it will require public education to explain why the level of service would not be any different than what real emergency open-line calls currently receive. Planned timeline for installation is January 2015.

### **Avista – Tower Colocation**

Avista has approached ECSO about leasing tower space on Elk Mountain. ECSO has been researching equivalent rates from around the state.

### **User Survey Results**

Earlier this year, a survey was sent to user agency personnel to gauge their opinions on ECSO performance issues. Through the ratings, comments and feedback, issues have been identified and are being addressed through training.

## **ADJOURNMENT**

There being no other business or public comment, Chair adjourned the meeting at 3:53 p.m. The next Intergovernmental Council meeting will be held on October 8, 2014 at 3:30 p.m. in the ECC Room at 400 Pech Road, Central Point, OR unless otherwise notified.
